1. **ONLINE CONTRIBUTION AGREEMENT BETWEEN NATIONAL TRUST FOR HISTORIC PRESERVATION (PAGE HOST) AND COMPANY/ORGANIZATION RECEIVING ONLINE CONTRIBUTIONS (CONTRIBUTION RECIPIENT):**

2. Contribution Recipient expressly acknowledges that they will receive 100% of the donations from the contribution page and that this money will be given to them by the **NATIONAL TRUST FOR HISTORIC PRESERVATION** on a monthly basis by direct electronic transfer.
3. Contribution Recipient expressly acknowledges that donors who are not already members of the **NATIONAL TRUST FOR HISTORIC PRESERVATION** will be offered a complimentary, one-year membership for their donation to the Contribution Recipient. For potential donors who are already members, this offer is null and void. Contribution Recipient also recognizes that **NATIONAL TRUST FOR HISTORIC PRESERVATION** members may not renew their membership by donating online to the Contribution Recipient. Membership will only be offered to donors not already associated with the **NATIONAL TRUST**.
4. Contribution Recipient recognizes that the **NATIONAL TRUST FOR HISTORIC PRESERVATION** will acknowledge donors immediately after contribution transaction to award them a one-year complimentary membership, and that the **NATIONAL TRUST FOR HISTORIC PRESERVATION** will notify the Contribution Recipient weekly of contribution transactions so that the Contribution Recipient may acknowledge their donors in a timely fashion.
5. Contribution Recipient expressly acknowledges that the names, addresses, and email addresses of the donors will be kept by the **NATIONAL TRUST FOR HISTORIC PRESERVATION** as member records and that these complimentary members will periodically receive contact from the **NATIONAL TRUST**.
